ORDINANCE ADOPTING MICHIGAN MOTOR VEHICLE CODE

An ordinance to adopt by reference the Michigan Motor Vehicle Code of the State of Michigan.

THE VILLAGE OF BANCROFT, SHIAWASSEE COUNTY MICHIGAN ORDAINS:

Sec. 1. CODE ADOPTED

The Michigan Motor Vehicle Code of the State of Michigan and all amendments thereto being 1949 Public Acts 300; MCL 257. et seq.; MSA 9.1801 et seq., pursuant to Public Act 255 of 1998 Section 4 being MCLA 66.4, (and all amendments thereto) is hereby adopted by reference.

Sec. 2. REFERENCES IN CODE

References in the Michigan Motor Vehicle Code "governmental unit" or "police officer", "law enforcement officer" or similar designation shall include the Village of Bancroft and its officers.

Sec. 3. NOTICE TO BE PUBLISHED

The Bancroft Village Clerk shall publish this ordinance in the the manner required by law and shall at the same time publish a supplementary notice setting forth the purpose of the said Michigan Motor Vehicle Code and of the fact that a complete copy of the Code is available through the office of the Village Clerk or the Police Department for inspection by the public during regular Council Meetings or by request by calling same. A copy of the Code may be obtained through the Clerk or Police Department for a fee which will not exceed the actual cost of same.

Sec. 4. WHEN EFFECTIVE

The Michigan Motor Vehicle Code will be in effect in this governmental unit (20) twenty days after the passage of this adopting ordinance.



Sec. 5. PUBLICATION

Within (15) fifteen days after the passage of this Ordinance it or a synopsis of same shall be published in a newspaper circulated in the Village. Immediately after publication, the clerk shall enter in the record of ordinances, in a blank space to be left for that purpose under the record of the ordinance, a certificate under the clerk's hand, stating the time and places of the publication.

Date of Publication: October 15, 1999.




Notice of Adoption of Michigan Motor Vehicle Code
