

ORDINANCE NO. 293 -18
VILLAGE OF BANCROFT
(Enacted February 14, 2018)

**AN ORDINANCE TO AMEND VILLAGE ORDINANCE NUMBER 243-07
REGARDING SIZE OF PLANNING COMMISSION**

The Village of Bancroft Ordains:

Village Ordinance Number 243-07, the Planning Commission Ordinance, enacted February 14, 2007 is amended as follows:

- “1. **Establishment:** The Village Council has previously created a Planning Commission formed under the authority of and subject to the powers, duties, and limitations provided in the Michigan Planning Enabling Act, Michigan Compiled Law (MCL) 125.3811, et al. The Village Council, by resolution, shall set the number of members of the Planning Commission at 5, 7, or 9, at the Village Council’s discretion, as permitted by Michigan Compiled Law (MCL) 125.3815 (2).
2. **Appointments and Terms:** As the number of new members is expanded, those persons appointed to newly added positions shall be appointed to terms of 1-year, 2-year, or 3-year terms such that, as nearly as possible, the terms of 1/3 of all the planning commission members will expire each year. Thereafter, members shall be appointed for 3-year terms. The size of the Planning Commission can be reduced to 5 or 7 members by eliminating member positions at the expiration of their term. If a vacancy occurs on a planning commission, the vacancy position shall be filled for the unexpired term of the position. A member shall hold office until his or her successor is appointed.
10. **Effective Date:** This Ordinance and any related rules, regulations, provisions, requirements, orders and matters established shall take effect immediately upon publication pursuant to MCL 66.1.”
12. **Repealer.** All Ordinances, or parts of Ordinances in conflict with this Ordinance are repealed only to the extent necessary to give all provisions of this Ordinance full effect.”
