ORDINANCE NO. 297-19 VILLAGE OF BANCROFT

(Enacted March 13, 2019)

ORDINANCE FOR MANDATORY CONNECTION TO VILLAGE WATER SUPPLY SYSTEM

An ordinance providing for the mandatory connection to the Village water supply system.

THE VILLAGE OF BANCROFT ORDAINS:

Section 1: Mandatory Connection.

- (A) All residential dwellings, structures, or real estate within the Village in which a supply of water is necessary for its use or occupancy, shall connect to the water system provided by the Village, if available. The water system shall be deemed available if the supply runs through or adjoins any public street, right-of-way, public property or easement, abutting the property upon which the dwelling or structure is located. Connection to the Village water system shall be mandatory, if available:
 - (1) For all new dwellings and structures;
 - (2) For any user whose existing private water supply system fails or requires replacement.

Section 2: Application required.

Any person, firm, corporation, entity, or other persons desiring the use of water furnished by the Village water system shall make written application to the Village Clerk, stating the street address and ownership of the residence, business, or area to be furnished water, and pay the Village Clerk the applicable connection charge as set by this resolution of the Village Council.

Section 3: The Village Clerk shall provide a copy of this Ordinance and a map of the location of the Village's water supply infrastructure system to the Shiawassee County Health Department for their utilization in determining whether or not a permit to drill a well shall be issued by the County. The Village Clerk shall provide updated maps of the Village's water supply infrastructure system to the Health Department as the supply system map may change.

Section 4: If any section, subsection, sentence, clause or phrase of this Ordinance is, for any reason, held to be invalid or unconstitutional, such decision shall not affect the validity or constitutionality of the remaining portions of this Ordinance. The Village of Bancroft declares that it would have passed this ordinance and each section, subsection, clause or phrase hereof, irrespective of the fact that any one or more section, subsections, sentences, clauses and phrases be declared unconstitutional.

Section 5: That this Ordinance and the related rules, regulations, provisions, requirements, orders and matters established shall take effect immediately upon publication, except any penalty provisions which shall take effect twenty (20) days after publication, pursuant to MCL 66.1.
