We had the furnaces worked on at the DPW building and the community hall. Phil noticed when he was parking the police cruiser that he smelled gas and there was a gas leak. B. Anthony Bogetta was kind enough to give us a discount on the furnace work and between him and Brian, Anthony also donated a new heating/cooling unit.
