DPW Report: Was given by B. Barnum; The continuation of moving and grinding leaves have continued. The township volunteered and came in and winterized the hydrants for us. There are some hydrants that need to be watched. The pump that we have doesn't have a long enough hose to reach the bottom therefore we have one ordered and should be here soon. Water testing is going well. Leaf blowers work well. The village was able to get the leaf vac for \$760.00 so it should be up and working for next year. The shipping container area has been grated graded and the well house road has been filled in where holes were with millings that we got from the Maple St project.

Police Report: Was Given, B. Barnum commented on how the traffic stops are still up.

Public Comments: There was a question on the special assessment for garbage. The question was in regard to the a sale of property and if the special assessment must be paid off by the seller because the way it reads, a title company would interpret it as it would have to be paid off by the seller. Attorney Christopher Johnson discussed the assessment with the inquiring individual and recommended changing the working wording on the resolution for better clarification. Another induvial individual asked about the Grand River Avenue village property that used to be used for yard waste if it would be cheaper to utilize that area again opposed to having the yard carts at each household. B. Barnum explained that the yard waste carts were more of a bonus when we did the contract that it wouldn't have changed the pricing. The village tried to keep the waste/refuse collection as close to a fixed cost as possible. Regarding not having the correct cans at each resident B, Barnum has a list of serial numbers for all of the cans and which household they belong to so if there is a problem, he can review the master list and try and find missing or extra cans and have them where they belong.
