- 4. **MEDC/Contribution:** Lion Bear will look for grants for the village. Grant writers are on staff. You can get funding from MEDC/RRC without being involved. There was a lack of following through from people that took the training. RRC disengaged but can engage us again. Justin Horvath set the Village up with Lion Bear. Kevin Bible spoke out the MOU contract not getting signed.

- 2. Village Hall Roof: need to get a scope of work beforehand.
- 3. Water Tower Bids/VFD's: Brian presented the council with the bids that the Village received. T. Terpening moved and supported by R. Miller to take the spring bid from Maguire Iron to do the repairs and painting of the tower minus the \$25,000.00 for the pressure tank for a balance of \$95,200. Roll call vote was taken.   - **T.** Terpening moved and supported by R. Miller to purchase and install VFD's from Northern Pump and Well for \$12,100.00. Roll call vote was taken. Bible, yes; Miller, yes; Terpening, yes; B. Barnum, yes. Motion Carried

**Add to Agenda under new business.** T. Terpening moved and supported by R. Miller to open agenda and add World Task Force Funding. All ayes, motion carried.

T. Terpening moved and supported by R. Miller to allow Brian Barnum sign the contract for World Task Force Funding to receive the Loss Revenue money of \$5727.17. Roll call vote was taken. Bible, yes; Miller, yes; Terpening, yes; B. Barnum, yes. Motion Carried

**Public Comment:** Ric Wright expressed his concern about why are we wasting contractor's time to come and get quotes for the Community Hall roof if there isn't enough money to even do the job.
