WHEREAS, the Village of Bancroft has certified and attested through Affidavit that, upon receipt of the grant award, the Village of Bancroft will implement all practices stated in section 979.a (2) (a-f) of Public Act 166 of 2022, which are designed to improve fund ratios moving forward.

WHEREAS, the Village of Bancroft is adopting this resolution for the purposes of qualifying for the Protecting MI Pension Grant as required on the application for same.

IT IS RESOLVED that the Village of Bancroft hereby authorizes the Village President to take all steps necessary to apply for and hopefully receive the Protect MI Pension Grant.
