

**VILLAGE OF BANCROFT
RESOLUTION NO. 2025-03**

**AUTHORIZING RESOLUTION FOR MICHIGAN COMMUNITY DEVELOPMENT
BLOCK GRANT (CDBG) FUNDING**

At a regular meeting of the City Council of the Village of Bancroft, held on June 11, 2025 at 7:00PM, at 120 Warren St., Bancroft, MI 48414, the following resolution was offered:

WHEREAS, the Village of Bancroft desires to establish a Homeowner Rehabilitation Program for owner-occupied single-family homes. (the “Project”); and

WHEREAS, the Village of Bancroft intends to apply to the Michigan State Housing Development Authority (MSHDA) for \$400,000 in funding assistance through the Community Development Block Grant (CDBG) Program; and

WHEREAS, the proposed Project is consistent with the community development plan adopted by the Village of Bancroft, as described in the application to be submitted to MSHDA; and

WHEREAS, all proposed Project activities will be undertaken for the primary purpose of providing and/or improving permanent residential structures that, upon completion, will be occupied by low- and moderate-income households; and

WHEREAS, no costs, whether funded by CDBG or non-CDBG sources, will be incurred prior to a formal grant award, completion of environmental review procedures, and the receipt of written authorization to incur costs from the designated CDBG Specialist; and

NOW, THEREFORE, BE IT RESOLVED:

1. That the Village of Bancroft authorizes the submission of an application for CDBG funding for the Project described above;
2. That the following individual is hereby authorized to sign the CDBG Application and all required attachments on behalf of the Village of Bancroft: Brian Barnum, Village President;
3. That the following individual is authorized to sign the Grant Agreement and any subsequent amendments: Brian Barnum, Village President;
4. That the following individual is authorized to submit FSR Payment Requests: Brian Barnum, Village President;
5. That the following individual is designated as the Certifying Officer for the purposes of environmental review and related compliance: Brian Barnum, Village President;

6. That all resolutions and parts of resolutions in conflict herewith are hereby repealed.
